

RINGKASAN

Penelitian efektivitas pengelolaan Dana Desa di Desa Petir Kecamatan Purwanegara Kabupaten Banjarnegara. Dana desa merupakan dana yang berasal dari APBN dengan mengefektifkan program berbasis desa secara merata dan berkeadilan. Tujuan pemerintah menganggarkan dana desa yaitu untuk meningkatkan kualitas pelayanan publik di desa, mengentaskan kemiskinan, memajukan perekonomian desa, mengatasi kesenjangan pembangunan antar desa, dan memperkuat masyarakat desa sebagai subjek pembangunan. Pengelolaan Dana Desa meliputi perencanaan, pelaksanaan, penatausahaan, serta pelaporan dan pertanggungjawaban.

Penelitian ini bertujuan untuk mengetahui efektivitas pengelolaan Dana Desa di Desa Petir. Metode yang digunakan dalam penelitian ini yaitu kualitatif deskriptif. Metode pengumpulan data melalui wawancara, observasi dan dokumentasi. Sumber data pada penelitian ini yaitu orang, tempat dan kertas (dokumen). Sedangkan analisis yang digunakan dalam penelitian ini yaitu analisis rasio efektivitas dan analisis efektivitas dari Duncan meliputi penjapaian tujuan, integrasi dan adaptasi.

Hasil penelitian menunjukkan bahwa efektivita pengelolaan Dana Desa di Desa Petir dari tahun 2018-2020 termasuk dalam kategori efektif karena nilai rasio efektivitas berada diatas 90%. Rasio efektivita spada tahun 2018 sebesar 96,6%, tahun 2019 sebesar 103,1% dan tahun 2020 sebesar 97,8%. Sedangkan berdasarkan analisis efektivitas dari Duncan menunjukkan bahwa efektivitas pengelolaan Dana Desa di Desa Petir efektif dalam bidang pembangunan desa. Meskipun pengelolaan Dana Desa di Desa Petir termasuk dalam kategori efektif, tetapi masih dijumpai permasalahan seperti kurang pahamnya masyarakat terkait dengan pengelolaan Dana Desa di Desa Petir.

SUMMARY

Research on the effectiveness of Village Fund management in Petir Village, Purwanegara District, Banjarnegara Regency. Village funds are funds originating from the APBN by making village-based programs more effective and equitable. The purpose of the government budgeting village funds is to improve the quality of public services in the village, alleviate poverty, advance the village economy, overcome development gaps between villages, and strengthen village communities as development subjects. Village Fund management includes planning, implementation, administration, as well as reporting and accountability.

This study aims to determine the effectiveness of Village Fund management in Petir Village. The method used in this research is descriptive qualitative. Methods of collecting data through interviews, observation and documentation. Sources of data in this study are people, places and paper (documents). While the analysis used in this study is the analysis of the effectiveness ratio and the analysis of the effectiveness of Duncan covering the achievement of goals, integration and adaptation.

The results showed that the effectiveness of the Village Fund management in Petir Village from 2018-2020 was included in the effective category because the effectiveness ratio value was above 90%. The effectiveness ratio in 2018 was 96.6%, in 2019 it was 103.1% and in 2020 it was 97.8%. Meanwhile, based on the effectiveness analysis from Duncan, it shows that the effectiveness of the management of the Village Fund in Petir Village is effective in the field of village development. Although the management of the Village Fund in the Petir Village is included in the effective category, there are still problems such as the lack of understanding of the community related to the management of the Village Fund in the Petir Village
