Tujuan penelitian ini menganalisis efektivitas pembinaan narapidana terorisme di Lembaga Pemasyarakatan *High Risk* Pasir Putih Nusakambangan dan kendala Lembaga Pemasyarakatan *High Risk* Pasir Putih Nusakambangan dalam pelaksanaan pembinaan narapidana terorisme. Pendekatan yuridis sosiologis, bersifat deskriptif, Untuk memperoleh data dan informasi yang berkaitan dengan permasalahan dan pembahasan penelitian. Penelitian ini mengambil lokasi di Lembaga Pemasyarakatan *High Risk* Pasir Putih Nusakambangan. Sumber data dalam penelitian ini meliputi data primer dan data sekunder. Karena belum berhasil merubah sikap ideologi dari radikal menjadi tidak radikal dengan indikator narapidana teroris tersebut membuat pernyataan ikrar setia kepada NKRI..

Kendala dalam pelaksanaan efektivitas pembinaan narapidana terorisme di Lembaga Pemasyarakatan *high risk* Pasir Putih Nusakambangan dalam struktur hukum yaitu tidak adanya konselor dan kurangnya jumlah *assessor*.

The purpose of this study was to analyze the effectiveness of fostering terrorism convicts in the High Risk Penitentiary of Pasir Putih Nusakambangan and the obstacles faced by the High Risk Penitentiary of Pasir Putih Nusakambangan in the implementation of the development of terrorism convicts. Sociological juridical approach, descriptive, to obtain data and information related to research problems and discussions. This study took place at the Nusakambangan High Risk Penitentiary. Sources of data in this study include primary data and secondary data. Primary data collection by interview, secondary data literature study. The data is presented in the form of a description, analyzed qualitatively.

Based on the results and discussion of the research on the effectiveness of fostering terrorism convicts at the Nusakambangan high risk Penitentiary, it was concluded that: Because they have not succeeded in changing their ideological attitude from radical to non-radical with the indicator that the terrorist convict has made a statement of his pledge of allegiance to the Unitary State of the Republic of Indonesia.

Constraints in implementing the effectiveness of fostering terrorism convicts at the Nusakambangan high risk Penitentiary in the legal structure are the absence of counselors and the lack of assessors.
