

**EFEKTIVITAS PERLINDUNGAN HUKUM PERAWAT DALAM
MELAKUKAN TINDAKAN MEDIS BERDASARKAN PELIMPAHAN
WEWENANG DOKTER DALAM PELAYANAN KEPERAWATAN

ABSTRAK

Penelitian ini bertujuan untuk mengetahui efektivitas perlindungan hukum perawat dalam melakukan tindakan medis berdasarkan pelimpahan wewenang dokter dalam pelayanan keperawatan dan pengaruh faktor kedisiplinan, kerjasama, dan fasilitas terhadap efektivitas perlindungan hukum perawat dalam melakukan tindakan medis berdasarkan pelimpahan wewenang dokter dalam pelayanan keperawatan di Rumah Sakit Umum Muhammadiyah Siti Aminah Bumiayu, Brebes. Penelitian ini menggunakan metode penelitian kuantitatif dengan pendekatan yuridis sosiologis, dan spesifikasi penelitian deskriptif. Lokasi penelitian ini di Rumah Sakit Umum Muhammadiyah Siti Aminah Bumiayu, Brebes dengan responden sebanyak 42 (empat puluh dua) orang perawat. Pengambilan sampel melalui metode *simple random sampling*. Data yang digunakan meliputi data primer dan data sekunder yang diperoleh dengan metode kuisisioner, dokumenter dan studi kepustakaan. Pengolahan data dilakukan secara *coding, editing*, dan tabulasi. Data disajikan dalam bentuk tabel dan teks naratif serta dianalisis dengan distribusi frekuensi analisis, tabel silang analisis, analisis isi dan analisis perbandingan. Hasil penelitian menunjukkan bahwa efektivitas perlindungan hukum perawat dalam melakukan tindakan medis berdasarkan pelimpahan wewenang dokter dalam pelayanan keperawatan di Rumah Sakit Umum Muhammadiyah Siti Aminah Bumiayu, Brebes adalah efektif. Hal ini dibuktikan dengan hasil penelitian terhadap 4 (empat) indikator meliputi efektifnya jaminan informasi yang benar, jelas, dan jujur dari pasien; efektifnya jaminan imbalan jasa; efektifnya jaminan menolak keinginan klien; dan efektifnya jaminan fasilitas kerja. Faktor kedisiplinan kerja, faktor kerjasama, dan faktor fasilitas berpengaruh secara positif terhadap efektivitas perlindungan hukum perawat dalam melakukan tindakan medis berdasarkan pelimpahan wewenang dokter dalam pelayanan keperawatan di Rumah Sakit Umum Muhammadiyah Siti Aminah Bumiayu, Brebes.

**THE EFFECTIVENESS OF NURSE'S LEGAL PROTECTION IN

ABSTRACT

This study aims to determine the effectiveness of legal protection for nurses in carrying out medical actions based on the delegation of authority of doctors in nursing services and the influence of discipline, cooperation, and facilities factors on the effectiveness of legal protection for nurses in carrying out medical actions based on the delegation of authority of doctors in nursing services at Muhammadiyah Siti Aminah Bumiayu General Hospital, Brebes. This study uses quantitative research methods with sociological juridical approach, and descriptive research specifications. The location of this research is the General Hospital of Muhammadiyah Siti Aminah Bumiayu, Brebes with 42 (forty two) nurses as respondents. Sampling through simple random sampling method. The data used include primary data and secondary data obtained by questionnaire, documentary and literature study methods. Data processing is done by coding, editing, and tabulation. The data is presented in the form of tables and narrative text and analyzed by frequency distribution analysis, cross table analysis, content analysis and comparative analysis. The results showed that the effectiveness of the legal protection of nurses in carrying out medical actions based on the delegation of authority of doctors in nursing services at the Muhammadiyah Siti Aminah Bumiayu General Hospital, Brebes was effective. This is evidenced by the results of research on 4 (four) indicators, including the effectiveness of guaranteeing correct, clear, and honest information from patients, the effectiveness of the guarantee of remuneration for services, the effectiveness of guarantees against client wishes, and the effectiveness of guarantees for work facilities. The work discipline factor, the cooperation factor, and the facility factor have a positive effect on the effectiveness of the legal protection of nurses in carrying out medical actions based on the delegation of doctor's authority in nursing services at the Muhammadiyah Siti Aminah Bumiayu General Hospital, Brebes.
