ABSTRAK

Penelitian ini bertujuan untuk mengetahui implementasi hukum pelimpahan wewenang delegasi dokter kepada perawat dalam pelayanan kesehatan dan pengaruh faktor kerjasama, fasilitas, dan motivasi terhadap implementasi hukum pelimpahan wewenang delegasi dokter kepada perawat dalam pelayanan kesehatan di Rumah Sakit Umum Daerah Prof. Dr. Margono Soekarjo Purwokerto.

Penelitian ini menggunakan metode penelitian kuantitatif dengan pendekatan yuridis sosiologis dan spesifikasi penelitian deskriptif. Penelitian ini berlokasi di Rumah Sakit Umum Daerah Prof. Dr. Margono Soekarjo Purwokerto dengan responden sebanyak 36 (tiga puluh enam) orang tenaga kesehatan. Pengambilan sampel penelitian menggunakan *simple random sampling*. Jenis sumber data meliputi data primer dan data sekunder yang diperoleh dengan menggunakan metode angket, dokumenter dan kepustakaan. Data yang terkumpul diolah menggunakan teknik *coding*, *editing*, dan tabulasi serta dianalisis dengan distribusi frekuensi analisis, tabel silang analisis, analisis isi dan analisis perbandingan.

Hasil penelitian menunjukkan bahwa implementasi hukum pelimpahan wewenang delegasi dokter kepada perawat dalam pelayanan kesehatan di Rumah Sakit Umum Daerah Prof. Dr. Margono Soekarjo Purwokerto adalah efektif. Hal ini dibuktikan dengan hasil penelitian terhadap 4 (empat) indikator meliputi efektifnya pelaksanaan tindakan memasang infus, efektifnya pelaksanaan menyuntik, efektifnya pelaksanaan imunisasi dasar, efektifnya tindakan medis lainnya yang dilakukan sesuai dengan kompetensi perawat. Faktor kerjasama, faktor fasilitas, dan faktor motivasi berpengaruh secara positif terhadap implementasi hukum pelimpahan wewenang delegasi dokter kepada perawat dalam pelayanan kesehatan di Rumah Sakit Umum Daerah Prof. Dr. Margono Soekarjo Purwokerto.

ABSTRACT

This study aims to determine the legal implementation of the delegation of authority of doctors in health services at the Prof. Regional General Hospital. Dr. Margono Soekarjo Purwokerto and the factors that influence the implementation of the law on delegation of authority from doctors to nurses in health services at the Prof. Dr. Margono Soekarjo Regional General Hospital Purwokerto.

This research uses quantitative research methods with sociological juridical approach and descriptive research specifications. This research is located at the Regional General Hospital Prof. Dr. Margono Soekarjo Purwokerto with 36 (thirty six) health workers as respondents. The research sample was taken using simple random sampling. Types of data sources include primary data and secondary data obtained using the questionnaire, documentary and library methods. The data collected was processed using coding, editing, and tabulating techniques and analyzed by frequency distribution analysis, cross table analysis, content analysis and comparison analysis.

The results showed that the level of implementation of the law on delegation of authority from doctors to nurses in health services at the Prof. Regional General Hospital. Dr. Margono Soekarjo Purwokerto is effective. This is evidenced by the results of research on 4 (four) indicators including the Implementation of the Action of Inserting an Infusion, Implementation of Injecting. Implementation of Basic Immunizations, other medical actions carried out in accordance with the competence of the Nurse. The factors that tend to influence the implementation of the law on delegation of authority from doctors to nurses in health services at the Prof. Regional General Hospital. Dr. Margono Soekarjo Purwokerto includes cooperation factors, facilities factors, and motivation factors.
