

**KESADARAN HUKUM MASYARAKAT TENTANG FUNGSI  
KEPEMILIKAN KARTU IDENTITAS ANAK (KIA) DI DESA

**ABSTRAK**

Penelitian ini bertujuan untuk mengetahui mengetahui tingkat kesadaran hukum masyarakat dan pengaruh faktor pendidikan, motivasi dan intensitas sosialisasi terhadap tingkat kesadaran hukum masyarakat tentang fungsi kepemilikan Kartu Identitas Anak (KIA) di Desa Pedagangan, Kecamatan Dukuhwaru, Kabupaten Tegal.

Penelitian ini menggunakan metode penelitian kuantitatif dengan pendekatan yuridis sosiologis dan spesifikasi penelitian deskriptif. Penelitian ini berlokasi di Desa Pedagangan, Kecamatan Dukuhwaru, Kabupaten Tegal, Provinsi Jawa Tengah dengan responden sebanyak 45 (empat puluh lima) anak. Pengambilan sampel penelitian menggunakan *simple random sampling*. Jenis sumber data meliputi data primer dan data sekunder yang diperoleh dengan menggunakan metode angket, dokumenter dan kepustakaan. Data yang terkumpul diolah menggunakan teknik *coding*, *editing*, dan tabulasi serta dianalisis dengan distribusi frekuensi analisis, tabel silang analisis, analisis isi dan analisis perbandingan.

Hasil penelitian menunjukkan bahwa tingkat kesadaran hukum masyarakat kepemilikan Kartu Identitas Anak (KIA) di Desa Pedagangan, Kecamatan Dukuhwaru, Kabupaten Tegal adalah tinggi. Hal ini dibuktikan dengan hasil penelitian terhadap 4 (empat) indikator meliputi tingginya pengetahuan hukum masyarakat, tingginya pemahaman hukum masyarakat, besarnya sikap hukum masyarakat yang setuju serta besarnya perilaku hukum masyarakat yang sesuai dengan Permendagri Nomor 12 Tahun 2016. Disamping itu diperoleh pula bahwa faktor pendidikan, faktor motivasi dan faktor intensitas sosialisasi Kartu Identitas Anak (KIA) cenderung berpengaruh secara positif terhadap kesadaran hukum masyarakat tentang fungsi kepemilikan Kartu Identitas Anak (KIA) di Desa Pedagangan, Kecamatan Dukuhwaru, Kabupaten Tegal.

***ABSTRACT***

*This study aims to determine the level of legal awareness of the community and the influence of educational factors, motivation and intensity of socialization on the level of legal awareness of the community about the function of ownership of Child Identity Cards (KIA) in Merchant Village, Dukuhwaru District, Tegal Regency.*

*This research uses quantitative research methods with sociological juridical approach and descriptive research specifications. This research is located in Merchant Village, Dukuhwaru District, Tegal Regency, Central Java Province with 45 (forty five) children as respondents. The research sample was taken using simple random sampling. Types of data sources include primary data and secondary data obtained using the questionnaire, documentary and library methods. The collected data was processed using coding, editing, and tabulating techniques and analyzed by frequency distribution analysis, cross table analysis, content analysis and comparison analysis.*

*The results showed that the level of legal awareness of the community ownership of Child Identity Cards (KIA) in Merchant Village, Dukuhwaru District, Tegal Regency was high. This is evidenced by the results of research on 4 (four) indicators including the high knowledge of public law, the high understanding of community law, the amount of legal attitude of the community that agrees and the magnitude of the legal behavior of the community in accordance with Permendagri Number 12 of 2016. In addition, it is also obtained that the education factor, the motivation factor and the intensity of the socialization of the Child Identity Card (KIA) tend to have a positive effect on the legal awareness of the community about the function of ownership of the Child Identity Card (KIA) in Merchant Village, Dukuhwaru District, Tegal Regency.*
