

RINGKASAN

Penelitian yang berjudul ‘‘Peran *World Bank* dan UNODC melalui *Stolen Asset Recovery* (StAR) Initiative dalam Upaya Pemulihan Aset Kasus Korupsi *1 Malaysia Development Berhad*’’ ini dianalisis berdasarkan konsep *asset recovery* dan teori kerja sama internasional. Fokus penelitian ini adalah menganalisis bagaimana kerja sama internasional antara *World Bank* dan UNODC melalui *Stolen Asset Recovery* (StAR) Initiative dalam upaya membantu Malaysia dalam pemulihan aset hasil korupsi kasus *1 Malaysia Development Berhad* (1MDB). Berdasarkan data-data yang diperoleh, kerja sama antara *World Bank* dan UNODC dalam upaya pemulihan aset hasil korupsi 1MDB melalui *Stolen Asset Recovery* (StAR) Initiative merupakan kerja sama internasional berbentuk kolaborasi yang membantu Malaysia dalam upaya pemulihan aset 1MDB melalui berbagai programnya. Melalui program tersebut, StAR membantu mengantarkan Malaysia dalam melalui tiga tahap *stolen asset recovery* yakni identifikasi dan penelusuran aset, pembekuan dan penyitaan aset, serta pemulihan dan pengembalian aset. Namun keseluruhan aset Malaysia yang berada di luar negeri belum kembali seutuhnya.

SUMMARY

The study entitled “The Role of World Bank and UNODC through the Stolen Asset Recovery (StAR) Initiative in an effort to Recover Asset Corruption 1 Malaysia Development Berhad Case” was analyzed based on the asset recovery concept and international cooperation theory. The focus of this study to analyze how the international cooperation between World Bank dan UNODC through the Stolen Asset Recovery (StAR) Initiative in an effort to assist Malaysia in recovering assets from the corruption case 1 Malaysia Development Berhad (IMDB). Based on the data obtained, the collaboration between the World Bank and UNODC is an international cooperation in the form of collaboration that helps Malaysia in efforts to recover IMDB assets through its various programs. Through the program, StAR helped Malaysia through three stages of stolen asset recovery, that is identification and tracking of assets, asset freezing and seizure, and asset recovery and return. But the overall assets of Malaysia which are abroad have not returned fully.
