

**KEPATUHAN HUKUM MASYARAKAT TERHADAP KEWAJIBAN
VAKSINASI COVID-19 DALAM RANGKA PENANGGULANGAN

ABSTRAK

Penelitian ini bertujuan untuk mengetahui kepatuhan hukum masyarakat terhadap kewajiban vaksinasi COVID-19 dalam rangka penanggulangan wabah menular dan pengaruh faktor pendidikan, faktor pekerjaan, dan faktor motivasi terhadap kepatuhan hukum masyarakat pada kewajiban vaksinasi COVID-19 dalam rangka penanggulangan wabah menular di Desa Ketenger, Kecamatan Baturraden, Kabupaten Banyumas.

Penelitian ini menggunakan metode penelitian yuridis sosiologis, serta spesifikasi penelitian deskriptif. Pengambilan sampel melalui metode *simple random sampling*. Jenis data yang digunakan adalah data primer dan sekunder. Metode pengumpulan data dilakukan dengan metode angket, studi kepustakaan, dan studi dokumenter. Metode pengolahan data dengan *coding*, *editing*, dan tabulasi. Penyajian data dalam bentuk tabel distribusi frekuensi, tabel silang dan teks naratif. Metode analisis data dengan tabel silang analisis, analisis isi dan analisis perbandingan.

Hasil penelitian menunjukkan tingkat kepatuhan hukum masyarakat terhadap kewajiban vaksinasi COVID-19 dalam rangka penanggulangan wabah menular di Desa Ketenger, Kecamatan Baturraden, Kabupaten Banyumas adalah tinggi, yang dibuktikan dengan melihat pada 4 (empat) indikator yaitu tingginya kepatuhan hukum terhadap pendataan sasaran penerima vaksin COVID-19, tingginya kepatuhan hukum terhadap jadwal dan tahapan pemberian vaksin COVID-19, tingginya kepatuhan hukum terhadap pencatatan dan pelaporan kejadian ikutan pasca vaksinasi COVID-19, tingginya kepatuhan hukum terhadap sanksi penolakan vaksinasi COVID-19. Faktor pendidikan dan faktor pekerjaan cenderung tidak berpengaruh secara signifikan terhadap kepatuhan hukum masyarakat pada kewajiban vaksinasi COVID-19 dalam rangka penanggulangan wabah menular di Desa Ketenger, Kecamatan Baturraden, Kabupaten Banyumas. Sedangkan, faktor motivasi cenderung berpengaruh secara positif.

ABSTRACT

This study aims to determine the community's legal compliance of the COVID-19 vaccination obligation to overcome the outbreak and the influence of educational factors, employment factors, and motivational factors on community legal compliance of the COVID-19 vaccination obligation in the context of overcoming infectious outbreaks in Ketenger Village, Baturraden District, Banyumas Regency.

This study uses sociological juridical research methods, as well as descriptive research specifications. Sampling through simple random sampling method. The types of data used are primary and secondary data. Methods of collecting data were questionnaires, literature studies, and documentary studies. The data processing methods with coding, editing, and tabulation. Presentation of data in the form of frequency distribution tables, cross tables, and narrative texts. Methods of data analysis with cross table analysis, content analysis, and comparison analysis.

The results show that the level of community legal compliance of COVID-19 vaccination obligations in the context of controlling the outbreak in Ketenger Village, Baturraden District, Banyumas Regency is high, as evidenced by looking at 4 (four) indicators, namely the high legal compliance of data collection on target recipients of COVID-19 vaccines, the high legal compliance of the schedule and stages of administering COVID-19 vaccines, the high legal compliance of recording and reporting follow-up events after COVID-19 vaccination, and the high legal compliance of sanctions for refusing COVID-19 vaccinations. Educational factors and employment factors tend to have no significant effect on community legal compliance of COVID-19 vaccination obligations in the context of controlling the outbreak in Ketenger Village, Baturraden District, Banyumas Regency. Meanwhile, motivational factors tend to be positive.
