**ABSTRAK**

Narkotika dalam Pasal 1 angka (1) Undang-undang Nomor 35 Tahun 2009 Tentang Narkotika adalah zat atau obat yang berasal dari tanaman atau bukan tanaman, sintetis atau semisintetis, yang dapat menyebabkan penurunan atau perubahan kesadaran, hilangnya rasa, mengurangi sampai menghilangkan rasa nyeri, dan dapat menimbulkan ketergantungan. Undang - undang Narkotika mengelompokkan rehabilitasi menjadi 2 (dua) jenis yaitu rehabilitasi medis dan rehabilitasi sosial. Rehabilitasi yang saat ini di teliti yaitu rehabilitasi sosial di Balai Rehabilitasi Sosial Korban Penyalahgunaan NAPZA Satria Baturaden.

Rumusan masalah dalam penelitian ini adalah apakah pelaksanaan rehabilitasi sosial di balai rehabilitasi sosial korban penyalahgunaan NAPZA di satria Baturaden terhadap pengguna Napza telah efektif dan apa saja hambatan-hambatan dalam pelaksanaan Rehabilitasi Sosial di Balai Rehabilitasi Sosial Korban Penyalahgunaan NAPZA Satria Baturaden terhadap pengguna NAPZA. Metode penelitian yang digunakan berupa pendekatan yuridis sosialogis, spesifikasi penelitian deskriptif analisis, metode peumpulan data yaitu wawancara dan studi kepustakaan (*Library Research*), metode analisis kualitatif.

Berdasarkan hasil penelitian dan pembahasan yang telah disimpulkan, pelaksanaan rehabilitasi sosial terhadap pengguna NAPZA di Balai Rehabilitasi Sosial Korban Penyalahgunaan NAPZA Satria Baturaden telah efektif dilihat dari indikator rehabilitasi dan program diselenggarakan secara prosedur. Faktor Penghambat pelaksanaan rehabilitasi sosial di Balai Rehabilitasi Sosial Korban Penyalahgunaan NAPZA Satria Baturaden yaitu Kurangnya Sumber Daya Manusia dalam tim Psikolog Klinis, Kurangnya Sarana Prasarana seperti tempat atau ruangan tambahan untuk tim Psikolog Klinis, Serta kurangnya perhatian dan kepedulian masyarakat terhadap NAPZA dan residen.

**ABSTRACT**

*Narcotics in Article 1 number (1) of Law Number 35 of 2009 concerning Narcotics are substances or drugs derived from plants or non-plants, synthetic or semisynthetic, which can cause a decrease lowered or altered consciousness, loss of taste, reduce to eliminate pain, and can lead to dependence. The Narcotics Law classifies rehabilitation into 2 (two) types, medical rehabilitation and social rehabilitation. The rehabilitation currently in research is social rehabilitation at the Social Rehabilitation Center for Drug Abuse Victims Satria Baturaden.*

*The formulation of the problem in the study is whether the implementation of social rehabilitation at the social rehabilitation center for drug abuse victims in Satria Baturaden against drug users has been effective and what are the obstacles in implementing Social Rehabilitation at the Satria Baturaden Social Rehabilitation Center for Drug Abuse Victims against drug users. The research method used is a sociological juridical approach, descriptive analysis research specifications, data collection methods is interviews and library research, qualitative analysis methods.*

*Based on the results of research and discussion that have been concluded, the implementation of social rehabilitation for drug users at the Social Rehabilitation Center for Drug Abuse Victims Satria Baturaden has been effective from the rehabilitation indicators and programs implemented procedural. The inhibiting factors for the implementation of social rehabilitation at the Satria Baturaden Social Rehabilitation Center for Drug Abuse Victims are the lack of human resources in the clinical psychologist team, lack of infrastructure such as additional places or rooms for the clinical psychologist team, and the lack of public attention and concern for drugs and residents.*
