

**KESADARAN HUKUM PEDAGANG PASAR TERHADAP PENCEGAHAN

ABSTRAK

Penelitian ini bertujuan untuk mengetahui tingkat kesadaran hukum pedagang pasar terhadap pencegahan covid-19 dan pengaruh faktor kedisiplinan, fasilitas dan lingkungan kerja terhadap kesadaran hukum pedagang pasar terhadap pencegahan covid-19. Penelitian ini menggunakan metode penelitian kuantitatif dengan pendekatan yuridis sosiologis dan spesifikasi penelitian deskriptif. Penelitian ini berlokasi di Pasar Wage Purwokerto dengan responden sebanyak 50 (lima puluh) orang pedagang pasar. Pengambilan sampel penelitian menggunakan *simple random sampling*. Jenis sumber data meliputi data primer dan sekunder yang diperoleh dengan menggunakan metode angket, dokumenter dan kepustakaan. Data yang terkumpul diolah menggunakan teknik *coding*, *editing*, dan tabulasi kemudian disajikan secara naratif dan tabel data. Analisis data kuantitatif menggunakan metode statistik sederhana, sedangkan analisis data kualitatif menggunakan metode analisis isi dan analisis perbandingan. Hasil penelitian menunjukkan bahwa tingkat kesadaran hukum pedagang pasar terhadap pencegahan covid-19 di Pasar Wage Purwokerto adalah tinggi. Hal ini dibuktikan dengan indikator-indikator yaitu tingginya tingkat pengetahuan pedagang pasar terhadap pencegahan Covid-19, tingginya tingkat pemahaman pedagang pasar terhadap pencegahan Covid-19, banyaknya sikap setuju pedagang pasar terhadap pencegahan Covid-19 dan banyaknya perilaku pedagang pasar yang sesuai dengan pencegahan Covid-19. Faktor kedisiplinan, fasilitas dan lingkungan kerja pedagang pasar cenderung berpengaruh secara positif terhadap tingkat kesadaran hukum pedagang pasar terhadap pencegahan covid-19, artinya semakin tinggi kedisiplinan, semakin baik fasilitas dan lingkungan kerja pedagang pasar maka semakin tinggi pula tingkat kesadaran hukum pedagang pasar terhadap pencegahan covid-19

ABSTRACT

This study aims to determine the level of legal awareness of market traders on the prevention of covid-19 and the influence of discipline factors, facilities and work environment on the legal awareness of market traders on the prevention of covid-19. This study uses quantitative research methods with a sociological juridical approach and descriptive research specifications. This research is located in Pasar Wage Purwokerto with 50 (fifty) market traders as respondents. The research sample was taken using simple random sampling. Types of data sources include primary and secondary data obtained using the questionnaire, documentary and library methods. The collected data is processed using coding, editing, and tabulating techniques and then presented in a narrative and data table. Quantitative data analysis used simple statistical methods, while qualitative data analysis used content analysis and comparison analysis methods. The results showed that the level of legal awareness of market traders regarding the prevention of covid-19 in Purwokerto's Wage Market was high. This is evidenced by the indicators, namely the high level of knowledge of market traders regarding the prevention of Covid-19, the high level of understanding of market traders regarding the prevention of Covid-19, the large number of agreeable attitudes of market traders towards the prevention of Covid-19 and the large number of behavior of market traders in accordance with the prevention of Covid. -19. Discipline factors, facilities and the work environment of market traders tend to have a positive effect on the level of legal awareness of market traders for the prevention of covid-19, meaning that the higher the discipline and facilities and the better the working environment of market traders, the higher the level of legal awareness of market traders towards preventing covid. -19
