ABSTRAK

Sadomasokisme merupakan aktivitas seksual yang memberi atau menerima kenikmatan dengan cara menyebabkan atau menderita rasa sakit yang dilakukan atas kesepakatan kedua belah pihak. Dalam penelitian ini membahas bagaimana praktik pemenuhan kebutuhan seksual pasangan suami istri penderita sadomasokisme dan bagaimana analisis kriminologis terhadap perilaku sadomasokisme dalam hubungan suami istri. Penelitian ini menggunakan metode pendekatan empiris dengan data yang digunakan adalah data primer berupa wawancara dan data sekunder berupa studi kepustakaan. Data yang telah diperoleh diolah dan dianalisis, lalu selanjutnya disajikan dalam bentuk teks naratif secara rinci dan sistematis. Hasil penelitian menunjukkan bahwa praktik pemenuhan kebutuhan seksual pada pasangan suami istri penderita sadomasokisme, dilakukan dengan melibatkan tindakan kekerasan mulai dari siksaan berupa pukulan, tendangan, dan menggunakan alat. Berdasarkan analisis kriminologis, sadomasokisme dapat dikaji secara etologi kriminal yang mana mencari sebab-sebab kejahatannya melalui faktor psikologi kriminal. Faktor psikologis dianggap sangat berpengaruh terhadap mereka yang menderita sadomasokisme.

ABSTRACT

Sadomasochism is a sexual activity that gives or receives pleasure by causing or suffering pain which is carried out with the agreement of both parties. This research discusses how the practice of fulfilling the sexual needs of married couples with sadomasochism and how the criminological analysis of sadomasochism behavior in husband and wife relationships. This research uses an empirical approach with the data used primary data in the form of interviews and secondary data in the form of literature studies. The data that has been obtained is processed and analyzed and then presented in the form of a detailed and systematic narrative text. The results showed that the practice of fulfilling sexual needs in married couples with sadomasochism was carried out by involving acts of violence ranging from torture in the form of hitting, kicking, and using tools. Based on the criminological analysis, sadomasochism can be studied in terms of criminal etiology which seeks to find the causes of the crime through criminal psychology factors.
