***ABSTRACT***

*The State of Indonesia is a rule of law based on democracy, to maintain public trust and oversee the running of the government so that there are no irregularities, supervision is carried out by internal or external oversight agencies. Supervision by the internal oversight agency within the executive power is carried out by the Financial and Development Supervisory Agency, the Inspectorate General, the Provincial Inspectorate and/or the Regency/City Inspectorate. The problem is that not a few people do not know the role or function of the Regional Inspectorate. This study uses a normative juridical approach with analytical descriptive specifications. This study uses data obtained from secondary data with data collection methods namely library research, documentary methods, and interviews. The research is presented in the form of narrative text and is analyzed qualitatively.*

*Based on the results of research and discussion of the Regional Inspectorate of Banyumas Regency, it has a role in carrying out supervision in the form of audits, reviews, evaluations, monitoring, and other supervisory activities on regional finances based on the Risk-Based Annual Work Program (PKPT). Supervision can also be carried out based on public complaints, requests from law enforcement officials or cooperation agreements with other agencies. Other Inspectorate roles such as conducting probity audits, cash taking, and stock taking. The supervision carried out by the Inspectorate is followed up by preparing a Results Report which contains recommendations.*
