

STUDENTS' LEGAL ASPIRATIONS TOWARD THE RULES PROHIBITING SEXUAL VIOLENCE ON CAMPUS

ABSTRACT

This study aims to determine the legal aspirations of students on the rules prohibiting sexual violence on campus as well as the influence of facilities and infrastructure, communication, and motivation factors on students' legal aspirations regarding the rules prohibiting sexual violence on campus at the Faculty of Law, Jenderal Soedirman University. This research uses quantitative methods, empirical juridical approaches, and descriptive research specifications. The research location is at the Faculty of Law, Jenderal Soedirman University. Sampling through a simple random sampling method. The data used includes primary and secondary data obtained by questionnaire, documentary, and literature. Data processing by coding, editing, and tabulation. Quantitative data analysis uses frequency distribution, cross-table analysis, content analysis, and comparative analysis. The results showed that the level of legal aspirations of students towards the rules prohibiting sexual violence on the campus of the Faculty of Law, Jenderal Soedirman University is moderate. This is evidenced by the results of research on 4 (four) indicators, including the moderate prevention of sexual violence on campus, the moderate level of handling of victims of sexual violence on campus, the poor mechanism for handling sexual violence on campus, and the moderate sanctions for perpetrators of sexual violence on campus. Meanwhile, facilities and infrastructure factors as social factors tend to have a less significant effect on students' legal aspirations about the rules prohibiting sexual violence on campus, and communication factors and motivational factors as personal factors have a positive effect on students' legal aspirations about the rules prohibiting sexual violence on campus.

ABSTRAK

Penelitian ini bertujuan untuk mengetahui aspirasi hukum mahasiswa terhadap aturan larangan kekerasan seksual di kampus serta pengaruh faktor sarana dan prasarana, komunikasi dan motivasi terhadap aspirasi hukum mahasiswa tentang aturan larangan kekerasan seksual di kampus di Fakultas Hukum Universitas Jenderal Soedirman. Penelitian ini menggunakan metode penelitian kuantitatif dengan pendekatan yuridis empiris, dan spesifikasi penelitian deskriptif. Lokasi penelitian di Fakultas Hukum Universitas Jenderal Soedirman. Pengambilan sampel melalui metode *simple random sampling*. Data yang digunakan meliputi data primer dan data sekunder yang diperoleh dengan metode angket, dokumenter, dan kepustakaan. Pengolahan data secara *coding*, *editing*, dan tabulasi. Analisis data kuantitatif menggunakan metode distribusi frekuensi analisis, tabel silang analisis, analisis isi, dan analisis perbandingan. Hasil penelitian menunjukkan bahwa tingkat aspirasi hukum mahasiswa terhadap aturan larangan kekerasan seksual di kampus Fakultas Hukum Universitas Jenderal Soedirman adalah sedang. Hal ini dibuktikan dengan hasil penelitian terhadap 4 (empat) indikator meliputi sedangnya pencegahan kekerasan seksual di kampus, sedangnya tingkat penanganan korban kekerasan seksual di kampus, kurang baiknya mekanisme penanganan kekerasan seksual di kampus, dan sedangnya sanksi pelaku kekerasan seksual di kampus. Sedangkan, faktor sarana dan prasarana sebagai faktor sosial cenderung kurang berpengaruh secara signifikan terhadap aspirasi hukum mahasiswa tentang aturan larangan kekerasan seksual di kampus, faktor komunikasi dan faktor motivasi sebagai faktor personal berpengaruh secara positif terhadap aspirasi hukum mahasiswa tentang aturan larangankekerasan seksual di kampus.
