ABSTRAK

Penelitian ini bertujuan untuk mengetahui implementasi hukum jaminan kesehatan bagi guru swasta dalam Sistem Jaminan Sosial Nasional (SJSN) serta pengaruh faktor fasilitas, faktor komunikasi, faktor kerja sama terhadap implementasi hukum jaminan kesehatan bagi guru swasta dalam Sistem Jaminan Sosial Nasional (SJSN) di MI Ma'arif Kecamatan Karangmoncol, Kabupaten Purbalingga. Penelitian ini menggunakan metode pendekatan penelitian kuantitatif dengan pendekatan analisis yuridis sosiologis dan spesifikasi penelitian deskriptif. Penelitian ini mengambil lokasi di MI Ma'arif Kecamatan Karangmoncol, Kabupaten Purbalingga dengan responden sebanyak 30 guru swasta. Pengambilan sampel penelitian menggunakan *simple random sampling*. Jenis dan sumber data meliputi data primer dan data sekunder yang diperoleh dengan metode angket, dokumenter, dan kepustakaan. Analisis data dengan menggunakan distribusi frekuensi analisis, tabel silang analisis, analisis isi dan analisis perbandingan. Hasil penelitian menunjukkan bahwa implementasi hukum jaminan kesehatan terhadap guru swasta dalam Sistem Jaminan Sosial Nasional (SJSN) di MI Ma'arif Kecamatan Karangmoncol, Kabupaten Purbalingga adalah efektif. Hal ini dibuktikan dengan hasil penelitian terhadap 6 (enam) indikator meliputi efektifnya pendaftaran peserta oleh pemberi kerja; efektifnya pembayaran iuran; efektifnya manfaat pelayanan; efektifnya memilih faskes (fasilitas kesehatan); efektifnya mendapatkan informasi; dan efektifnya pelaporan perubahan data. Faktor fasilitas dan faktor kerjasama berpengaruh secara positif, serta faktor komunikasi cenderung kurang berpengaruh terhadap implementasi hukum jaminan kesehatan terhadap guru swasta dalam Sistem Jaminan Sosial Nasional (SJSN) di MI Ma'arif Kecamatan Karangmoncol Kabupaten Purbalingga.

ABSTRACT

This study aims to determine the implementation of health insurance law for private teachers in the National Social Security System (SJSN) and the influence of facility factors, communication factors, cooperation factors on the implementation of health insurance law for private teachers in the National Social Security System (SJSN) in MI Ma'arif, Karangmoncol District, Purbalingga Regency. This research uses quantitative research approach method with sociological juridical analysis approach and descriptive research specifications. This research took place in MI Ma'arif, Karangmoncol District, Purbalingga Regency with respondents as many as 30 private teachers. Research sampling using simple random sampling. Data types and sources include primary data and secondary data obtained by questionnaire, documentary, and literature methods. Data analysis using frequency distribution, cross table analysis, content analysis and comparative analysis. The results showed that the implementation of the health insurance law for private teachers in the National Social Security System (SJSN) in MI Ma'arif, Karangmoncol District, Purbalingga Regency was effective. This is proven by the results of research on 6 (six) indicators including the effectiveness of participant registration by employers; effective payment of contributions; effective service benefits; the effectiveness of selecting health facilities (health facilities); the effectiveness of obtaining information; and effective reporting of data changes. Facility factors and cooperation factors have a positive effect, and communication factors tend to have less influence on the implementation of health insurance laws for private teachers in the National Social Security System (SJSN) in MI Ma'arif, Karangmoncol District, Purbalingga Regency.
