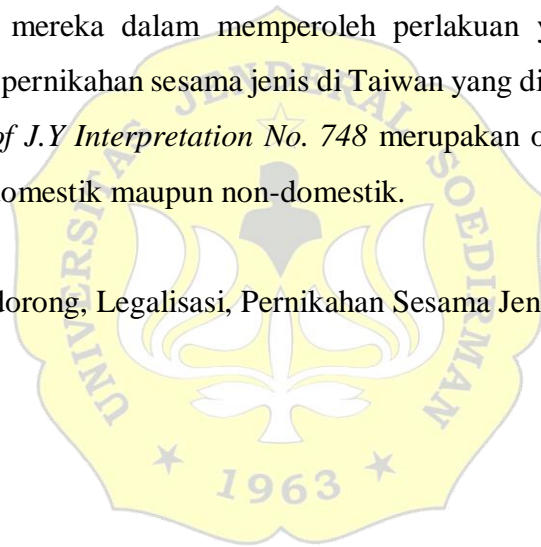


RINGKASAN

Penelitian yang berjudul “Analisis Faktor Pendorong Legalisasi Pernikahan Sesama Jenis di Taiwan Tahun 2017-2019” dianalisis menggunakan teori *policy-making process* dan teori queer. Fokus dalam penelitian ini adalah faktor-faktor yang melatarbelakangi Taiwan melegalisasi pernikahan sesama jenis. Penelitian ini menggunakan teori *policy-making process* Gabriel Almond untuk mengidentifikasi input, yakni tuntutan dan dukungan dalam legalisasi pernikahan sesama jenis di Taiwan; memahami proses perumusan kebijakan yang melibatkan konstitusi/pemerintahan Taiwan; serta mencari pengaruh struktur kabinet pemerintahan Taiwan pasca pemilu 2016 terhadap legalisasi pernikahan sesama jenis di Taiwan. Penelitian ini juga menggunakan teori queer Michael Warner dalam memahami tuntutan dan dukungan yang diperjuangkan oleh aktivis pejuang hak LGBT Taiwan, khususnya bagi homoseksual, agar mendapat hak-hak mereka dalam memperoleh perlakuan yang sama dengan kaum heteroseksual. Legalisasi pernikahan sesama jenis di Taiwan yang diatur secara khusus melalui *Act for Implementation of J.Y Interpretation No. 748* merupakan output dari berbagai faktor pendorong dari lingkup domestik maupun non-domestik.

SUMMARY

The study entitled “The Driving Factor Analysis of Same-Sex Marriage Legalization in Taiwan 2017-2019” was analyzed by the policy-making process theory and queer theory. The focus of this research is the factors that underlie Taiwan in legalizing same-sex marriage. This study applied policy-making process theory of Gabriel Almond to identify the inputs, i.e., demands and supports on same-sex marriage legalization in Taiwan; comprehend the policy formulation process that is involving Taiwan’s constitution/government; as well as seek the effect of Taiwan’s government cabinet structure post-election 2016 on the legalization of same-sex marriage in Taiwan. This study also utilized queer theory of Michael Warner to conceive Taiwanese LGBT rights activists’ demands and supports, for homosexuals particularly in order to obtain their rights to acquire equal treatment as heterosexuals. The legalization of same-sex marriage in Taiwan that individually regulated through Act for Implementation of J.Y Interpretation No. 748 is the output of various driving factors from domestic and non-domestic.
